To grant a general mandate to the directors of the Company to allot, issue and deal with additional shares (including any sale or transfer of treasury shares of the Company out of treasury) not exceeding 20% of the total number of issued shares of the Company (excluding treasury shares of the Company) as at the date of passing of this resolution.		
9.	To extend the general mandate granted to the directors of the Company pursuant to ordinary resolution no. 8 to allot, issue and deal with additional shares by the aggregate number of the shares bought back by the Company under ordinary resolution no. 7.

- In order to be valid, this form of proxy, together with the power of attorney or other authority, if any, under which it is signed or a certified copy of that power of attorney or authority, must be deposited at the Company’s branch share registrar in Hong Kong, Tricor Investor Services Limited, at 17/F, Far East Finance Centre, 16 Harcourt Road, Hong Kong not less than 48 hours before the time appointed for the meeting (i.e. not later than 10:00 a.m. on Wednesday, 26 June 2024) or the adjourned meeting (as the case may be).
- Completion and delivery of this form of proxy will not preclude you from attending and voting at the AGM if you so wish.
